

# Cookie policy

When you visit the Parnasse websites or mobile application, cookies might be stored on your computer, tablet or mobile device in order to improve your experience with us. This page explains how cookies are used, and how to manage them.

## 1. WHAT IS A COOKIE?

The term “cookie” refers to a number of similar tools or functionalities to store or access information on your device (computer, tablet, mobile device, smart TV, etc.) when visiting our website or mobile application, or when interacting with us.

Cookies themselves are a small text file in alphanumeric format stored on the device to remember you and your preferences. But there are also other similar technologies serving the same purpose, such as tags, SDKs, pixels embedded into pages you visit, or the use of your browser’s local storage to store information.

## 2. WHAT ARE COOKIES USED FOR?

Cookies are tools enabling Parnasse to collect information about your device or online activity for different purposes.

### 2.1. Cookies that are strictly necessary for our website and mobile application to function properly

These cookies are essential for you to be able to visit our website and mobile application, and allow you to access all the proposed functionalities.

They might include cookies that collect session IDs and identification data, or cookies that remember your preferred interface, for example if you have chosen a specific language or accessibility options.

This also includes cookies that allow you to consent to the use of cookies that are not strictly necessary.

These cookies cannot be disabled from our interfaces.

Warning: our website and application may not work correctly if you disable strictly necessary cookies from your browser.

## 2.2. Cookies requiring your consent

Parnasse needs your consent before storing and using cookies for certain purposes.

### 2.2.1. Website usage statistics cookies

These cookies allow us to monitor our website and application traffic and usage and help us to improve the quality of our offers and services.

As an example, they allow us to analyze the use of our pages and journeys, to better understand how you interact with us to build sites and applications that are better suited to your needs. This might include improving the usability of a page or ensuring that our content is relevant to you.

And if one of our pages is not working properly, these cookies will tell us.

These cookies are kept for 13 months, and collected data is kept for 25 months.

### 2.2.2. Personalization cookies

These cookies allow us to personalize your experience with Parnasse.

We use your usage data and your customer profile to personalize your experience on our website and application, by offering tailored content or offers. We may also test several versions of the website and offer you one to improve your browsing experience and make it more relevant.

We can also use data about your interaction with us through our website and application to personalize communications that we send you by email, post, call or SMS/MMS, depending on your contact preferences.

These cookies are kept for 13 months, and collected data is kept for 25 months.

### 2.2.3. Social media cookies

Parnasse offers social media share buttons that allow you to share our site's content with other people.

The social media website might identify you through this button, even if you have not used it when viewing our site, if you browse from a session for which you are signed in with your login

details. Parnasse does not control any subsequent processing by these social media sites. You can manage your preferences directly from your account interfaces with these social media sites.

## 3. CONFIGURING THE USE OF COOKIES

### 2.1. Scope of your preferences in terms of cookies

If you indicate your preferences whilst signed in, we will remember and observe these preferences regardless of the device used on our website and application.

If you are not signed in and your tablet, computer or phone is used by several people, or if this device has multiple browsers, Parnasse will only consider the preferences of the person who indicated them last. Parnasse will use all available data, which might correspond to the activity of another user.

### 2.2. Managing your preferences from the Parnasse interface

You can indicate your cookie preferences from the information banner shown on your screen when you visit our website or application.

You can change your preferences at any time by withdrawing or giving your consent from the Profile / Privacy / Cookie management menu or at the bottom of the page "[Cookie Management](#)".

### 2.3. Configure your browser

In your browser settings, there are various features to automatically accept or reject all or some cookies on all or some websites that you visit.

You can also delete some or all cookies stored on your device from your browser.

You are free to use the browser of your choice, which will offer different settings and features.
